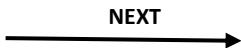
THIS IS A REQUIRED FORM FOR ALL SALTY DOG DOGGY DAYCARE PARTICIPANTS RECEIVING SERVICES. First and foremost, the safety and well-being of your pet(s) is of the highest importance. Insuring that your pet remains safe and well cared for is our first responsibility, and as such we take it very seriously. We do our best to have our per parents screen for pre-existing health conditions, but some factors may be beyond our control. In the event that a medical emergency arises while a pet is at our facility or participating in a service that we provide, it is imperatives that we are immediately able to get them medical treatment at the closest available facility. We will call ahead to veterinary offices in the closest proximity geographically to us to insure that they can handle the emergency present. Your pet will be rushed to the closest available facility and you will be notified. We notify the owner after we have secured a medical treatment center for the animal to avoid delays that may be caused by emotion on the part of the owner. Our goal is to get your pet medical attention as quickly as humanly possible, and any distractions may interfere with that process.

For that reason it is a requirement to have our pet parents sign this form.

I understand that in the event of a medical emergency, SALTY DOG DOGGY DAYCARE (B & B PET SERVICES LLC), at its sole discretion, deems to need the immediate attention of a licensed veterinarian. I authorize Salty Dog Doggy Daycare (B & B PET SERVICES LLC) to seek medical attention at the closest available veterinary facility. I further agree that I am financially responsible for any medical treatment my pet(s) receives as a result of a medical emergency while attending services provided by Salty Dog Doggy Daycare(B & B PET SERVICES LLC).

PET CARE AGREEMENT

1. I further understand that Salty Dog Doggy Daycare (B & B PET SERVICES LLC) has relied upon my representation that my dog is in good health and has not injured or shown aggression or threatening behavior to any person or dog in admitting my dog for services at their facility.
2. I further understand that Salty Dog Doggy Daycare (B & B PET SERVICES LLC), their owners, staff, partners and volunteers, will not be liable, financially or otherwise, for injuries to my dog, myself or any property of mine while my dog is participating in services provided by Salty Dog Doggy Daycare (B & B PET SERVICES LLC). I hereby release Salty Dog Doggy Daycare (B & B PET SERVICES LLC), of any liability of any kind arising from my dog’s participation in any and all services provided by Salty Dog Doggy Daycare (B & B PET SERVICES LLC).
3. I further understand and agree that any problems with my dog, behavioral, medical or otherwise will be treated as deemed best interest of the animal. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog.
4. I further understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risk. I desire a socialized environment for my dog while attending services provided by Salty Dog Doggy Daycare (B & B PET SERVICES LLC), and while in their care, I understand that while socialization and play is closely and carefully monitored by Salty Dog Daycare (B & B PET SERVICES LLC) staff to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs. Any injuries to my dog will be pointed out by the staff upon pick-up. I further understand that there is a 3 strike policy at Salty Dog and if my dog misbehaves to an unsafe extend 3 times, my dog is not eligible to participate in daycare anymore.
5. I understand that allowing my dog to participate in services offered by Salty Dog Doggy Daycare (B & B PET SERVICES LLC). I hereby agree to allow Salty Dog Doggy Daycare (B & B PET SERVICES LLC) to take photographs or use images of my pet in print form or otherwise publication and/or promotion.
6. I further understand that I am solely responsible, financially or otherwise, for any harm or damage caused by my dog while my dog is attending any services provided by Salty Dog Doggy Daycare(B & B PET SERVICES LLC).
7. I understand that my dog cannot exceed the 1 month pack policy. If my dogs does, they will need another scheduled appointment. I also understand that I need to keep track of my dogs’ visits so I know when I will be exceeding that limit.

IMPORTANT PACK POLICY:

SINCE OUR PACK IS CONSTANTLY GROWING, ALL DOGS WHO ATTEND DAYCARE MUST COME ONCE EVERY 1 MONTH. THOSE WHO DO NOT COME FOR A TIME PERIOD LONGER THAN 1 MONTH MUST DO ANOTHER EVALUATION TO ASSURE EVERYONE GETS ALONG. BY SIGNING THIS SHEET YOU UNDERSTAND THAT YOUR RESPONSIBLE OF KEEPING TRACK OF YOUR DOGS ATTENDENCE. WE ALSO HAVE 3 STRIKE RULE HERE AT DAYCARE AND IF YOUR DOG MISBEHAVES 3 TIMES IN AN UNSAFE MANNER, THEY WILL NOT BE ALLOWED TO ATTEND DAYCARE

LATE FEE POLICY

PLEASE PICK UP YOUR DOG BEFORE 7PM.

WITH OR WITHOUT A PHONE CALL, YOU WILL BE CHARGED \$1/MINUTE AT 7PM

DAYCARE DROP OFFS ARE FROM 6 AM – 12:30PM

*WE NO LONGER ACCEPT PARENTS TO DROP OFF DOGS AFTER 12:30PM DUE TO THE PACK ALREADY SETTLING DOWN.

LEASH POLICY:

*ALL DOGS MUST ENTER AND EXIT THE BUIDLING ON A LEASH AT ALL TIMES

*PLEASE HAVE YOUR DOGS NAME/LAST NAME CLEARLY LABELED OR HAVE SOMETHING ON IT THAT IS EASIER TO POINT OUT TO AVOID LEASH MIX UPS

COLLAR POLICY:

NO PRONG COLLARS

PLEASE TAKE OFF YOUR DOGS PRONG COLLARS BEFORE ENTERING THE BUILDING, THEY ARE VERY DIFFICULT TO GET OFF WHEN DOGS ARE VERY EXCITED TO PLAY AND FOR THE SAFETY OF OUR STAFF, IT IS BEST.

PAYMENTS/BALANCE FEE

*ALL PAYMENTS ARE EXPECTED AT PICK UP OR AT DROP OFF.

*THOSE THAT EXCEED A WEEK WITHOUT PAYING THEIR BALANCE THERE WILL BE A "LATE PAYMENT FEE" OF \$10 PER WEEK THAT A BALANCE IS UNPAID

VACCINATION POLICY:

For dogs that attend daycare regularly, we will inform you when your pups vaccinations expire. We will hand out a "vaccination sheet" that will specify which vaccination(s) expired. We expect an up dated copy within a couple of weeks. Those vaccinations are required for daycare. If we do not receive updated copies within that time period, then your pup will have to take a leave of absence from daycare until we acquire them

RABIES, KENNEL COUGH, DISTEMPER

ALL DOGS MUST BE FIXED IN ORDER TO ATTEND OUR DAYCARE WHEN THEY ARE OF AGE. IF THEY START TO "HUMP" BEFORE THEN, THEY WILL NEED TO TAKE A BREAK UNTIL THEY DO FOR THE SAFETY OF THE OTHER DOGS WHO ATTEND

PACKAGES ARE PAID UPFRONT:NOBODY IS ALLOWED TO USE MULTIPLE DAYS ON A PACKAGE WITHOUT IT BEING PURCHASED. FAILURE TO PAY FOR THE PACKAGE, YOU WILL BE CHARGED THE DAILY RATE INSTEAD OF THE DISCOUNTED PACKAGE RATE. PACKAGES ARE PAID UPFRONT AND THAT IS WHY YOU GET THE DISCOUNT.
